SOLAR

REQUIREMENTS & GUIDELINES

- Architectural drawings to be drawn up by an architectural professional. (Plan size: A1 2 Sets)
- Roof plan required indicating the layout and position of the proposed installation
- A dimension section depicting the proposed panels and their highest point. Height restriction line to be indicated on the section.
- A note specifying that all parts of the panel and its fixing will be in black.
- Flat roofs-: no section of the panel should be protruding above the roof kerb or a suitable screening approved by the ARP.
- Flat Roof Installation Requirements: "Installation at no more than 200mm at the lowest point and max. 6° angle of panels.
- Solar panels on sloping/ pitched roofs are to cover the entire roof.

WATER STORAGE TANKS

REQUIREMENTS & GUIDELINES

- Architectural drawings to be drawn up by an architectural professional. (Plan size: A1 2 Sets).
- Water tanks are permitted in the enclosed service/ courtyard areas, underground or in the garage. Water tanks are not permitted in the planting servitude or road side.
- Application to be submitted showing exact position of the tank. This can be marked on a copy of a site plan of your property depicting the exact location on site.
- Google earth images and photos around the location of the tanks is to be included in each application.
- Dimensions and volume of tanks is to be shown -Tanks larger than 5000lt are not permitted.
- SABS Compliant.
- Timber or plant screening required if not in the areas mentioned above/ depending on the area.
- Colour to be as dark as possible. No painting of polyethylene tanks is permitted.
- If the property is leased and the tenant is making application, written approval is required from the owner authorizing the installation, size, and position of the tank. If the tank is more than 2000lt the owner needs to make application directly.

BURNING OF THE GRASSLANDS

The Conservation trust has conducted their annual burning regimes on the 04th of August 2022. We are glad to report that it was another successful event for the Conservation Trust.

Burning of the Grasslands were done on blocks 4 and 5 this year and the balance will be done next year followed by a rest period of a year for the entire area (in all probability) before resuming the programmed in 2025.
