FACIAL RECOGNITION UPDATE

We have received feedback from residents regarding issues with the facial recognition readers. In response, both the HOA and Marshall Security have made the necessary adjustments, which have helped reduce the issues experienced.

However, upon further review, Marshall Security has identified that some difficulties are due to factors such as glare from windows, proximity to the reader, or overly dark window tinting, which can affect the system's ability to clearly detect a person's face.

For residents who are still experiencing issues, we kindly request that you email the HOA office, who will investigate and address the concerns.



FEEDING OF MONKEY'S

MY ESTATE LIFE - ISSUING OF CODES

Ensuring the safety of our community is a shared responsibility and security remains our highest priority. Please remember that the My Estate Life app is directly linked to your property address.



Sharing or generating access codes for other properties or providing them to agents for viewing other units is strictly prohibited.

If you need to arrange access for an agent or contractor visiting a different property, the property owner must email both the HOA office and security for authorisation purposes.

Once the authorisation is received, Security will generate a code accordingly.

Unauthorised issuing of codes can compromise the communities' security. Your support in following these guidelines helps maintain a safe environment for everyone.
